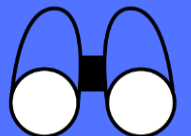

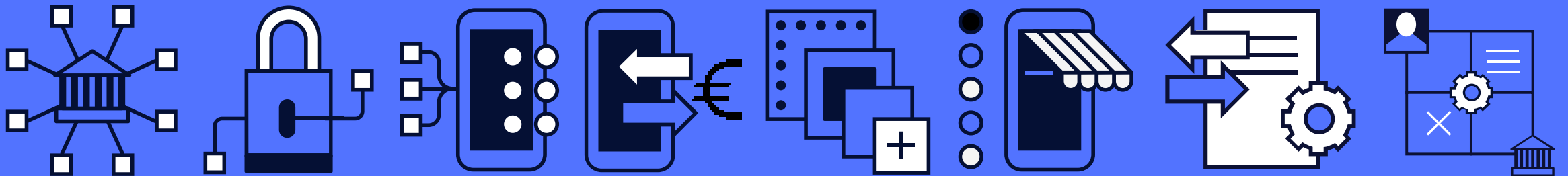
Key responsibilities will include to work on the following tasks together with our Head of Legal & Compliance:
